

## **The Chevy x Ella Langley Sweepstakes**

### **Official Rules**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING.**

Sweepstakes may only be entered in or from the 50 United States and the District of Columbia and entries originating from any other jurisdiction are not eligible for entry. This Sweepstakes is governed exclusively by the laws of the United States. You are not authorized to participate in the Sweepstakes if you are not located within the 50 United States or the District of Columbia.

**1. How to Enter.** During the Sweepstakes Period (defined below), (i) access the Instagram application on your mobile device; and (ii) go to Sponsor's designated Instagram post announcing the Sweepstakes ("**Sponsor's Sweepstakes Post**"), located @Chevrolet and comment to Sponsor's Sweepstakes Post, describing how you or your family has been impacted by breast cancer, including as a survivor, current patient, caretaker, or close friend or family member.

**2. Sweepstakes Entry Start/End Dates.** Sweepstakes begins at 2:00 PM Eastern Time ("ET") on October 9, 2025 and ends at 2:00 PM ET on October 16, 2025 ("Sweepstakes Period").

**3. Eligibility.** Participation open only to legal residents of the fifty (50) United States and the District of Columbia, who are at least eighteen (18) years of age and the age of majority in their state of residence. Void outside of the 50 United States, the District of Columbia, and where prohibited, taxed or restricted by law.
